CLUB CHARTER AND GOALS

Esperance Goldfields Surf Life Saving Club was formed after a public meeting called by the Apex Club in 1989, following the drowning of two boys. The main goal being to educate the youth of the town in surf safety. A previous club was formed in 1929, but disbanded.

Since the 1990/91 season, Club members have patrolled Twilight Beach and its surrounds providing surf life saving and first aid support to the surfing public and the beach community. The Club has educated the youth both through Nippers and within the Education Department's curriculum.

The Club has been affiliated with Surf Life Saving Western Australia and therefore with Surf Life Saving Australia since its inception.

It is now one of 315 Clubs which form Surf Life Saving Australia.

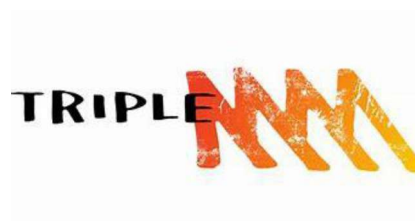
The Club is now an incorporated body under the terms and conditions of the Associations Incorporation Act 1987 (WA).

**WOODSIDE NIPPER PROGRAM
COORDINATOR OF THE YEAR – Janine Doney
(Finalist)**

Janine has been the Director of Juniors for the past 3 years. Every Sunday morning, she packs up her three children before 7am to participate and deliver the Woodside Nipper Program to the Esperance Goldfields SLS community.

Prior to the 21/22 season commencing, Bunnings Esperance invited EGSLS to conduct a Father's Day Raffle from their foyer. Janine attended this on EGSLS behalf for the whole day and was instrumental in attracting additional Nipper families and fundraising for the club!

Janine continuously throughout the week prior, communicates effectively with her Age Group Managers to maintain continuity and efficient training & fun for the Nippers.

Janine has been responsible for attracting a large amount of EGSLS parents to participate in the Nipper Rescue Certificate to keep our Nippers safe in the water. Every week she ensures, her eight AGM has adequate water

safety support prior to Nippers hitting the beach.

While ensuring all Safety procedures are met during a hectic time prior to the 9am Nipper start, Janine is also attending & welcoming any potential new Nipper families with a warm and open heart. Janine is a very genuine person with no background of her own in SLS.

Statistics show that EGSLS Nipper membership rate has increased, I believe, due to having a well organised Woodside Nipper Program and dedicated Director of Juniors. Janine looks after all the Woodside Nipper merchandise and ensures the club has enough for the season. Janine ensures that her AGM are well supported & recognised and across the Nipper attendance app to maintain the fluent up to date information she requires.

This year we scheduled in the Club of Events Calendar an overnight Sleep Over at the Club for U13s Age Group to prepare the transition into Youth, unfortunately we were unable to follow through with this activity due to Volunteer Burnout, but Janine is already working towards this goal next season.

Janine has been very good at communication on behalf of the club via her passion for social media. Janine has been instrumental at keeping our Facebook & Instagram page alive and bright with her regular updates.

Janine attended a membership forum in 2021, supporting the club with gaining additional knowledge with what happens behind the scenes. This is a fantastic experience for any club member.

Janine balances her Director of Junior role with actively being on a Patrol Team in the ARTC role and volunteered 30 hours this season. Janine is also Volunteer Ambulance Officer in Salmon Gums district and works in Executive Services at the Salmon Gums Primary School.

From her employment role, for the past two years, Janine introduced Salmon Gums Primary School (SGPS) the opportunity to participate in a day in the life of a Nipper & Surf Life Saver at EGSLSC. The whole school attended, insisted it was the best day of school. The SGPS Special Needs Assistant personally thanked the club, insisting it was seen as an excursion for children & staff, quoting “mental health for the whole school”!

In 20/21, Janine won the Club’s Most Dedicated Member Award, nominated by club members.

Peter has been instrumental to our club as an Age Group Manager. Peter has been an AGM since 2015. He has instructed a variety of Age Groups over the years. Peter takes his role

very seriously and this season has stepped up his commitment to the club.

In the 2021/22 season Peter Fox was responsible for Under 11’s. As with all Age Group Managers he had a variety of skill level in his group to encourage. Peter ensured he took his Woodside Nipper U11 file home each week after Nippers in order to be well organised and ready with the required skill set for the following session. He allowed himself time to provide the best outcome for his group.

While delivering the U11 Woodside Nipper Program, Foxy encouraged many nippers of the group to challenge themselves and compete in Country & State SLS competitions, while providing support on the sidelines. He kept the U11’s group invested with encouragements of challenging themselves with adventure swims and board paddles to the iconic Twilight Rock as a sweetener.

This year, Pete mentored a trainee Youth AGM for the whole season to provide her the confidence & skills to manage an Age Group herself effectively. Foxy’s age group were always the last to leave the beach every Sunday. He ensured his U11 group gained full ocean awareness and mentored children in respect & manners to the ocean, beach safety and people as a whole!

In addition to Sunday, Foxy provided Water Safety in Youth Board training every Tuesday & Thursday early mornings, supporting the Youth Coach. Being in Esperance and the troubles our town encounters with marine life, the club & youth were very grateful for his reliability & assistance.

Peter Fox provides water safety for EGSLSC at Bremer Bay Rainbow Coast & Albany Carnivals. Encouraging all participants to keep trying their best. Peter is always reliable with volunteering his support for the club. He

regularly raises his hand to provide Water Safety for the Australia Day Swim each year.

Foxy regularly Patrolled all season as a Bronze, completing 42 hours and recently added to his list of SLS education awards, an intense IRB Crew Course when Gary, John & Jay visited the club in April.

Peter Fox watches from afar with great proudness, seeing EGSLSC Cadets & Youth, further developing their skill set and seeing how far they have come for the humble beginnings of the Nipper program into well-grounded individuals always trying their best.

**YOUNG VOLUNTEER OF THE YEAR –
CASEY CRUTTENDEN**

Casey is an outstanding member at EGSLSC, he contributed to the club in the 21/22 season, volunteering 48 Patrol Hours. From this valuable contribution, Casey received the Club Patrolling Award at the end of our season.

He put his hand up at the 2021 Annual General Meeting and took a committee position as the Club's Building Officer. Casey is currently an apprentice carpenter and is using his newly acquired skills and hand tools, regularly assisting with getting the clubhouse ready for future building upgrades.

Casey Cruttenden is the perfect example of what the Lifesaving Pillar is all about and continuously rises through the ranks every opportunity he can. Regularly, while on his Patrols, Casey keeps the EGSLSC Youth engaged by, giving them experience with getting the IRB ready, quietly preparing them as future IRB Crew, and keeping them engaged during a long 6-hour Patrol by including all youth in regular ATV rides, patrolling the 3km beach.

Casey often hands the Club Radio's over to the Youth to gain confidence in relaying messages back to the Tower or Patrol Captain during Patrols. Assisting them with the correct terminology and speaking slowly & clearly.

As soon as Casey turned 18, he became a Silver Medallion IRB Driver and this year has outstandingly achieved receiving Rescue Watercraft Operator Certificate (Jet ski), taking annual leave from his carpentry apprenticeship to achieve this outcome.

Casey is always first to his Patrol opening the gate, setting up the beach and last to leave. He is regularly scanning the beach while attending the clubhouse even while not on Patrol.

Casey always supports our Club competition officer, often setting up the tricky water string line, dropping buoys/cans in place, always on hand for IRB water safety during Woodside Nippers Program & Club Swims and anything else we require him to do. He never complains, just quietly gets on with it and happy to assist.

Casey doesn't seek accolades or recognition; he just enjoys the club family SLS environment.

Unfortunately, this year Casey was unable to participate in State & Regional events due to his current work commitments, but I can see Casey pursue an interest in IRB competitions once our club is able to offer this training.

It won't be long until Casey joins Chris Brien and the Wesfarmers Esperance Emergency Response Jet Ski Team.

Casey won the inaugural State Youth Club Achiever & Youth of the Year in 2020. This young man is an outstanding individual and his continuous contributions should be recognised. EGSLSC are very grateful that Casey, now a young adult, continues to Patrol and be involved with the club.



VOLUNTEER OF THE YEAR – KELLY BUTTLE

Kelly Buttle became an accidental club president when mid way through the 2019 season EGSLC didn't have one. In the two years since she has dedicated most of her free time and energy into the revitalisation of the Esperance Goldfields Surf Life Saving Club.

Our local club is one of the more isolated WA SLS clubs operating from a stand alone building with self-sufficient power and water. Much like a small farm there is always things needing

repair, maintenance and updating and Kelly has been there every week, sometimes several times a day calling on a band of volunteers (often her own family) to bring machinery, tools and skills to keep the club open.

From fixing the roller doors, changing the locks, repairing the water pump, the heater, the phone reception, speaker, microphones, coffee machine. There's not a problem that doesn't seem to fall in the realm of Kelly's responsibility, and where maintenance of specific equipment requires the expertise of other club members you can bet Kelly is there helping, watching and learning so she knows what to do next time.

As part of her commitment to EGSLSC and surf life saving in general, Kelly this year faced a personal challenge and obtained her Bronze Medallion. She has been on a regular patrol roster, participates in club swims and events and has been a role model to those members who hadn't considered themselves capable of being part of the patrol team.

She got thrown off the Esperance Jetty in the middle of winter to raise money for the club in the local radio stations "Toss the Boss" promotion, I know we are a surf club but that shows amazing dedication during an Esperance winter.

During the 2021/22 season Kelly has had new remote control Patrol Doors installed, replaced the leaky Bore Tank, purchased a Flammable Liquids Cabinet to keep us & the club safer, achieved VIP parking space at the Yacht Club for our Surf Boat. She has organised the club rooms to be equipped with Wi-Fi and a Smart TV for education purposes and made Square available for our Nippers sausage sizzle.

She is committed to rewarding our hard working cadets for their service to the club and refurbished the club with inviting seating and a new Ping Pong table.

We are not a wealthy club and so in order to fund these repairs and upgrades, Kelly has spent more hours than she can count applying for grant funding. The total of her fundraising this season amounts to \$45,887 across six successful grant applications.

Her own family company also made generous donations to fund club upgrades which enable her vision for a welcoming first class club to be met.

Kelly has overseen the necessary renovation and upgrade of our kitchen, meeting with builders, planner and tradesmen over the course of a protracted construction process. Kelly spend innumerable hours, possibly several hundred applying for various grants to enable her vision for improvement to be met.

The existing EGSLSC club building never received an Occupancy Permit when it was completed in August 1995. In 2014 the Shire imposed restrictions on the club rooms use. EGSLSC were not allowed to hold functions or rent it out to other organisations, limiting our income and ability to help other groups in Esperance.

Kelly was aware of this when she took on the role as President and has worked tirelessly to resolve the issue. A building upgrade was the preferred option and Kelly has worked on developing the design, securing a \$300,000 grant from the shire and progressing options. Additional funding grants have been applied for to assist with the works budget as the compliance work has been costed well above this budget. Progress is ongoing. She has met with the Shire and political leaders to promote our cause and problem solve solutions. With significant delays affecting construction in the last 18 months there has been no end to the headaches in achieving compliance.

In addition to these extensive building works Kelly is working to improve another long standing infrastructure problem. The EGSLSC storage shed which houses Nipper equipment and boards is falling down, was broken in to late this season and requires replacement. There is currently no storage on site for Emergency Response Equipment or surfboats and so these are housed in various locations up to 10km from the surf club in residential sheds. Kelly has presided over the design, budgeting, town planning approval and numerous funding applications to get this project under way. Currently waiting on BBRF application process and hopefully approval.

Kelly Buttle lives and breaths EGSLSC, she spends more time making our club a home than she does her own. She adds simple things like shower caddies and plush bath mats to make everyone more comfortable, and always brings home made slice for patrolling members, thanking them all for the valuable work they do. When she is on patrol, tidying up, thanking people, noticing the work our members and trainers do and gives no clue to the hours she has already devoted the club at home. She works through the week for the club then gets out at Nippers every weekend.

Kelly is the first to publicly congratulate the achievements of every member, through from nippers, cadets and our senior members to our trainers and water safety volunteers. She has been at every carnival cheering for our members and helping with the little kids. No award, record or personal best escapes her notice and our members appreciate the recognition she generously offers. Our Nipper families are encouraged to look to the cadets and patrolling members as role models and Kelly, as president embodies this herself. Kelly is an outstanding President and an incredible asset to our club.



President Report Kelly Buttle

2021/22 has been a big one! Navigating the season with significant Covid 19 Management Strategies and continue to maintain the inclusive club culture was a high priority. The community support our Club has seen this past twelve months has been incredible. Since last year's AGM, EGSLSCL Board of Management & Committee team have hit the ground running.

The Club calendar of events was the usual,



jammed packed full of activities for Seniors, Youth, Nippers, including many community obligations. The Clubhouse open morning for new members in late October 2021 was well attended, even the adults enjoyed the Shrek Inflatable.

A trial to this season was Scotty's coffee adding to the calendar to visit the grass area once a month, was enjoyed by members big & small.

Membership increased for 21/22 season, especially with Woodside Nippers, which saw an increase of parent participants in the 10.30am Sunday club swim each week.

This positivity reflects the work the club contributes via socials. Thank you, Kara Murphy, Director of Operations, and your team, for your tireless commitment to maintaining the ongoing communication & social activities.



EGSLSC Patrol roster was successfully navigated by newly appointed Director of Lifesaving, Tim Ammon. In November we had a Patrol Toolbox Sundowner inviting Patrolling members to chat about the season ahead, regarding equipment, patrol teams and timelines. The first patrol of the season began on the first Sunday in December and included a Patrol Breakfast to celebrate.



Part of Tim's induction was a TV interview by Channel 7 with regards to the benefits of the recently acquired community St John Ambulance Tourniquet Kits located around Esperance coastline! Was certainly a talking point, (slightly dropped in it – welcome to the BOM)!

Once again, the use of the older SLS rescue boards positioned outside the clubhouse and down at beach level on the staircase for out of hours – were used to save swimmers in trouble on at least two occasions.

21/22 season no lives were lost on our watch. Although, there was 72 rescues & 359 preventative actions throughout Patrolling season. Thank you, Tim Ammon, for your professional and supportive commitment shown in your new role.



The club's growth saw additional participation in a highly successful Bremer Bay Rainbow Coast Carnival in November, run by Denmark club. It was great to see the adults enjoying the competition/training aspect of the Bremer Bay carnival. Thanks to Steve Baker,

Director of Competition & Coaching for ensuring our members are fully supported and information is communicated effectively at all events, your enthusiasm & motivation is well noted & appreciated.





Broome 2022 saw 50 EGSLS members travel to Broome to attend the Sunset Carnival.

Interestingly, more Master competitors on the beach this year than Youth & Nippers. Great opportunity for everyone to get involved with this competition. I am sure my team won the relay! Huge thank you to the Esperance crew that supported this carnival through water safety, marshalling, setup & pack up, so proud of our club. The Broome Camp School, Cliff to Crack was a highlight. Esperance had five teams entered, participation was for all members young & not so young. Thank you to Broome Camp School for welcoming & hosting EGSLS. This is not to be taken for granted, we are very appreciative of the opportunity we are given with regards to the BCS facility. It was unfortunate that our numbers were capped at 50 and members missed out.



The second year of the Christmas Bake-Off saw a variety of treats come to the table. Congratulations to the winner of the Judge & People's Choice Award, Tash Synott won both with her amazing creation. Thank you to Craig Adams, club member & Fish Face chef for judging the competition – very serious in his role. This event promotes enthusiasm, conversation & competition amongst our members.



Last year, Esperance Sports Star of the Year was re-established, and we were fortunate to nominate Lawson Baker on behalf of our club as the committed humble athlete & ambassador he is. Although he didn't win Junior Sports Star of the Year, he should be very proud of what he has achieved and the role model he is to the younger generation of the club.



Jayme Bergman, newly appointed Director of Education, nailed the organising of Training & Education. With support of club's trainers & assessors the club trained up an additional 9 Surf Bronze & 3 SRC members to join the Patrol roster.



After the season we were fortunate to have three Metro trainers visit for a week to provide upskilling of IRB drivers & IRB crew for 22/23 season. Thank you, Jayme, for your commitment to this role.





This year, EGSLSCL was fortunate to receive great success with Grant Application Funding:

- Stronger Communities Program (Round 6) – received \$19k towards the new Members kitchen – this was a huge highlight to the season, seeing the completion of this project and how well received by the members.



- Aurizon Community Giving Fund - \$10k for two new remote control Tilt Panel patrol doors.



- CBH Grass Roots Grants - \$9.8k Harvesting our own Rainwater – currently as I type, two new 2500ltrs slimline rainwater tanks, UV treatment filter, pump & gas HWS are being installed to have rainwater plumbed to the members kitchen and new water fountain.



- Being a Healthways club has enabled EGSLSC to receive \$3.8k towards purchase & temp installation of new Rainwater Fountain, which will reduce the club's plastic water bottle usage.



- Southern Ports Grant Partnership - \$1.8k purchase new 160lt Flammable Liquids Cabinet.



- Qube Bulk supporting Communities – \$2.5k enabled the club to purchase two new Shade Canopies for the Tower & Drone/Nipper area – arriving in August 2022.

- Horizon Power Community Partnership – \$7.7k small equipment purchases, includes s/s 4 bay bike rack, Square Terminal, Portable Labeller, Wheelbarrow, Sack Trolley, Small lockable Fridge, Shelving for training room, Aluminium Weather Resistant Notice Board, Portable P.A System, Aluminium Ladder, Lockable Cabinet for Patrol shed, additional Perspex to reduce wind in Tower, Retractable Hose Reel, Safety Floor Mats.

- Sport & Recreation COVID Cleaning Subsidy - \$2k

- Volunteering WA Grant – \$1k allowed our valuable club volunteers to be thanked by celebrating National Volunteers week with Breakfast by the Sea. This was a highly successful gathering, until we smoked the generator ☹️





Fundraising began with support from Triple M Radio Station - Toss the Boss in July 21, Bunnings Father's Day Raffle, Esperance Ag

Show setting up/pack up indoor stadium, Beach Safe Annual Street Appeal, Waitressing for the Shire Staff Christmas Luncheon at the Bowling Club. Unfortunately, due to COVID restrictions, the Annual Turf Club Carparking Duties & tin rattle was cancelled.



EGSLSC are currently waiting to hear back from Round 6 BBRF application submitted in February 22 with regards to \$205k funding towards the new ER & Patrol Storage Facility. Applications went into mothball mode during the federal election campaign and appears to remain in that state while I write this report!



Valuable fundraising & donations allows for additional purchases to be made for the club. This, I feel promotes an improved volunteer & club member experience. We purchased bean bags, Smart 75" TV for delivery of Education and Ice Age, new mobile whiteboard, stainless steel food trolleys, Table Tennis, Wi-Fi, Square reader for kiosk, new Bore Tank and the infamous Lectern.

The Woodside Nipper Partnership provides the club with \$7k worth of funding towards the delivery of the Nipper Program each season. Caps, hats, bags & Hi Viz vests for the Nippers also comes under the contribution Woodside make to the club. It certainly has assisted with keeping Nippers affordable for all children. We are in the third of a five-year contract.

Tab Meerman in her role as Director of Administration & Finance, has made the purchases/acquittals of all the ingoings & outgoings extremely transparent. I am so lucky to have her by my side. Your efficiency & reliability has been appreciated by all BOM & Committee, most of all me.

This year for the SLSWA Awards of Excellence (AOE) 2022, our club was extremely proud to have four nominations:

- Young Volunteer of the Year – Casey Cruttenden
- Woodside Nipper Coordinator of the Year – Janine Doney

We were thrilled to receive news that Janine Doney went through to be a finalist, although

she didn't win the award, she certainly is a winner for our club. The way Janine calmly handles the madness of the lead up to the beginning of Nippers each Sunday morning is inspirational.

At AOE night, EGSLSC life member, Mr Chris Brien was inducted into the SLSWA Life



Membership Hall of Fame, with his commitment to SLS & ER. Congratulations Chris, so pleased I was there to celebrate such an achievement.

In June 2022, Chris Brien was also awarded Emergency Service Medal from the Queen's Birthday Honours List for over 25 years commitment to Emergency Response. He will be heading to Perth to meet Kim Beasley in September for the ceremony. Well-deserved Chris.



All through the year, EGSLSC continues to harvest positive partnerships with supporting the local & regional community. This year we had Ocean Heroes provide surfing lessons at Twilight. Salmon Gums Primary school attended for a day in the life of a

Nipper/Lifesaver. Esperance Primary School, Year 6 class celebrate leavers day, spending time at Twilight Beach. Home care visits were welcomed on the verandah. Esperance Shire One and all children program included a session at EGSLSC. Soon we will see Mallee School's come to the club for a period during their town week. The Cannery arts has requested shelter when they host an Artist workshop at Twilight Beach in August.

How lovely to be involved with the Christmas Pageant every year – love seeing the smiles on the children's faces and the crowd when we roll past. Thank you to the organisers that take on this task. It gets better every year.

June 2022, Tim Buckman (via Zoom) and I visited the Shire Council Chambers at request from the Shire Councillors to gain more information about our Community Grants Program application for part funding to build a new storage facility.

In July 22, we received news from the Shire Grants Community Officer, we were successful with application. Securing \$152k to contribute towards building the new ER & Patrol Storage Facility, which demonstrates to members, the support coming through. Thank you, Tim Buckman, your professionalism, and background in the building industry flowed through at the presentation.

I am still working towards obtaining additional funding to secure for the Club Priority 1 & 2 upgrades. Watch this space. These goals were set in 2019/20 and we are moving towards the process.

None of this is achievable without the support of our sponsors, partners, members & volunteers. I would like to sincerely thank everyone who is involved with this inclusive club....

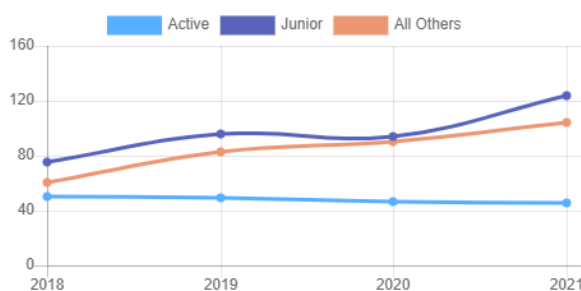




**Director of Finance and

The 2022 financial year presented many challenges for our Club. Some challenges we faced were coming out of COVID restrictions, Clubroom compliance, being broken into and having goods stolen plus aging equipment.

Despite this, the Club continued to grow. As shown on the graph below, Memberships for the 21/22 season saw an increase in Junior Members (includes Cadets), Active members remain constant and a slight growth in other types of Memberships (EG Community, Life members etc)



In 2020/21 Season we had 226 Financial Members, this Season saw an increase to 273. Hopefully this trend continues next season as we continue to provide a safe and fulfilling experience to members.

\$123,790 TOTAL REVENUE (FY22) Including Grant Income v \$57,746 (FY21)

This year our club's membership revenue was the major club generated source, accounting for \$18,112.50. Continued support from Woodside (\$6,782) for the Nipper program (3rd Year of 5), Toss the Boss (\$8,004.62) donated funds from the local radio station and Containers for Change (\$334.10) assisted with the Clubs income. Successful running of the

Community Award program (\$4,581.82), Merchandise Sales (\$8,335.39) and Sausage

Sizzles (\$3,792.61) were other Club generated revenue.

Members volunteered at various events and functions to help raise funds. Events/Functions were

- the Shire of Esperance Christmas Party. The funds received (\$375) from this event were used to purchase a new table tennis table and equipment.
- The Esperance & Districts Show Society with the setting up and packing up of the pavilion, generating \$800.
- Support for the Triathlon Club and Schools contributed \$1,150.

Thank you to our members who volunteered at these events, without you the Club would not have received these funds.

Due to our current building compliance restriction, we are unable to hire our Club for functions or events.

To assist with the current limitation, our Club generated supplementary income from multiple successful grant applications. This enabled the Club to upgrade aging equipment and work towards gaining the valued Building compliance needed.

Surf Life Saving contributed \$15,000 to put towards updating or purchasing new beach safety equipment. These funds were spent on valuable training equipment such as Training Defibrillators, Emergency Tourniquet and Clotting Trainer. The first Aid room received a new examination couch, trolley, stool, Sharps container and Glove dispenser. Patrol members received Waist Bags containing First Aid kits and whistles, Rescue Tubes, Fins, Waterproof Radio Cases, Binoculars, Soft Rescue Board and IRB Launch signs. Also purchased to assist Patrol Captains was a mobile phone and Ipad for reporting requirements.

We also received a new IRB and motor donated from DFES. Exemption for registration costs for IRB's were applied for and successful.

Stronger Communities contributed \$19,000 towards our kitchen upgrade. This also helps with our compliance requirements. Unfortunately, due to building market restrictions, costs exceeded original costings.

Aurizon contributed \$10,000 towards replacing the roller doors on the Club House. New tilt doors were installed by local installer, Chris Burr, who also donated \$2,200.

CBH Grassroots awarded us \$9,795 to upgrade our rainwater harvesting. This allowed us to update and install new tanks, filtration and pump. These works were carried forward to the 22/23 season as they are being used with additional funding from Healthways to install a Water Bubbler (fountain).

Southern Ports supported us with the purchase of a Flammable Liquids Cabinet (\$1789)

Qube Bulk donated \$2,292.17 towards new shade marquees. These were ordered at the end of the 21/22 season and will be utilised in the 22/23 season.

EMAR also assisted in the purchase of Club House items such as Lectern, Whiteboards, Microphone and Bean Bags.

Where was the money spent?

\$3,704 was spent on our Patrols. These expenses include Repairs and upgrades to the Patrol Trailer, including an awning to provide shade for Beach positioned members. Signage to warn the public of vehicles crossing the walking path on the ramp between club house and beach, new system to erect beach patrolling Flags and supplying lunch for patrolling members.

First Aid Supplies (\$2,265.48) were updated and new items such as Pulse Oximeters and Bleed Control Kits were purchased outside the Beach Safety Grant. Regular costs include the Oxygen cylinder charges, Defibrillator servicing and First Aid Kits.

General Club House and Board maintenance were carried out, with additional funds spent on Board covers for members to use when transporting to carnivals/events. Unexpected expenditure occurred after our Club House was broken into and various items stolen. Some items were later recovered.

Updates to Club House facilities included TV to replace the projector used during training programs, Orbi router for improved internet, Square terminals for use with sausage sizzle and Club events to reduce the amount of cash handled and Whiteboards for communications at various points of the Club.

A second hand racing Mal and Ski Paddles were purchased.

Nipper costs included updating equipment to assist Age Group Managers, New Water Safety Rashies and providing Sunscreen to our members.

Cleaning Costs over the COVID times has been heavily subsidised by member Maadi Little, who has generously donated her time cleaning and maintaining our Government mandated COVID requirements. We thank you for keeping us safe over these times.

In Conclusion

In the Audited Financials it shows our Net Profit as \$39,973. This total excludes the Kitchen upgrade expenses (\$28,110) which have been journaled to Club House Improvement Costs. The Auditor has also advised that the Expense Grants/Subsidies Paid to Competitors Expense Code was incorrect and this line should read GST Adjustments that related to 2021.

Additionally, not reflected in the Audited Financials, are the Grant Funds not acquitted this financial year. The CBH Grass Roots Grant for the Water Harvesting upgrades and installation of the Water Bubbler from Healthways were carried forward to 22-23. These Grants totalled \$13,595.

I'd like to acknowledge and thank the Board on a successful 21/22 season. Thank you must also go to my team for their support and contribution.

Tash for being the Registrar and MPIO. The start of the season is always chaotic, but you are there assisting and welcoming new and old members. Throughout the season you create posters/social media posts promoting our Club, unofficial events/club photographer, BBQ Chef, assisting with any enquiries and jumping in whenever asked. Also designing our Annual Report Cover Page – Thank you.

Rochelle for managing, sourcing and selling our Club Merchandise. Our new bathers have been constantly praised and I know you have been exploring some new items for next season. I can't wait!

Sara for organising the Sausage Sizzle roster and shopping each week to make sure there was a tasty treat when hungry kids came off the beach.

Dane & Casey for all the work you have done around the Club House and on Club equipment. Often asked to fix, source, purchase and build whatever is required.

Lastly, thank you to EVERY Member who supports our Club and embraces the Surf Family. Every contribution helps, big or small, land or ocean. **THANK YOU!**

Under 6 group receiving the 'Toss the Boss' cheque from TripleM, sponsored by community businesses, which will go towards the club refurbishment.

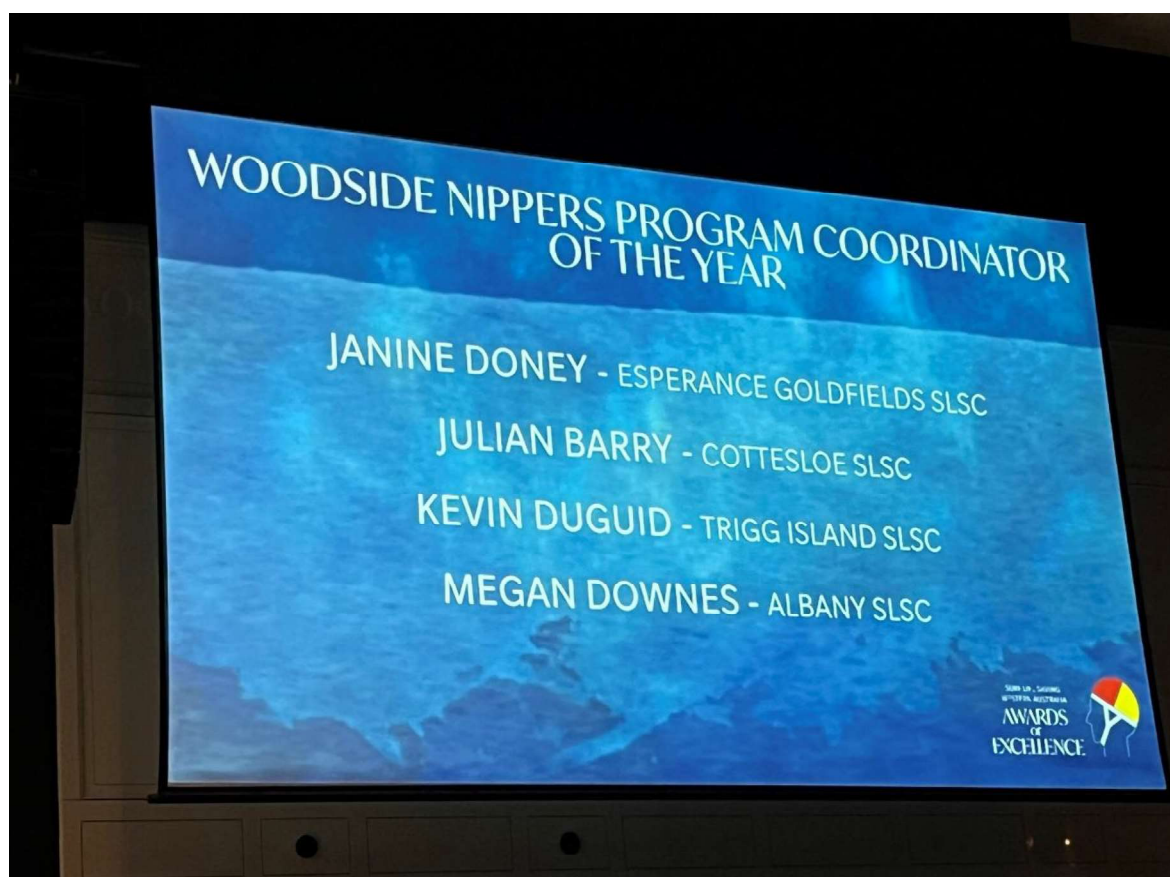
Participation at Bremer Rainbow Coast Carnival, where our team took out the trophy.

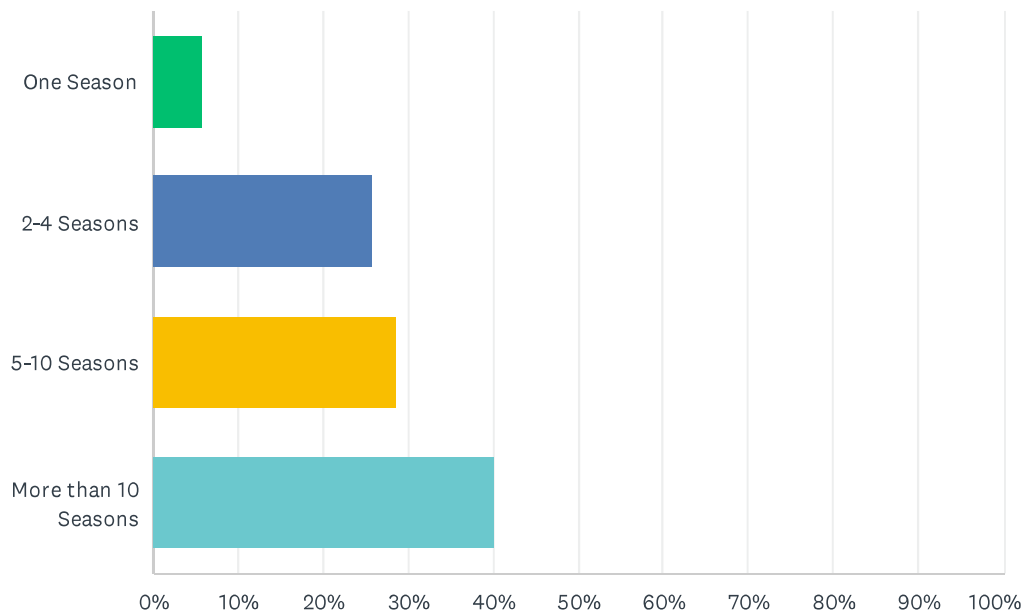

Q1 How long have you been a member of EGSLSC?

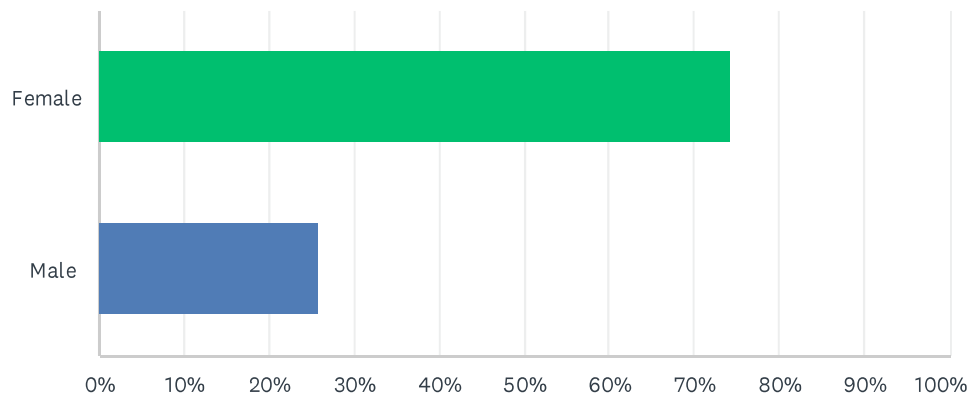

Q2 What is your gender?

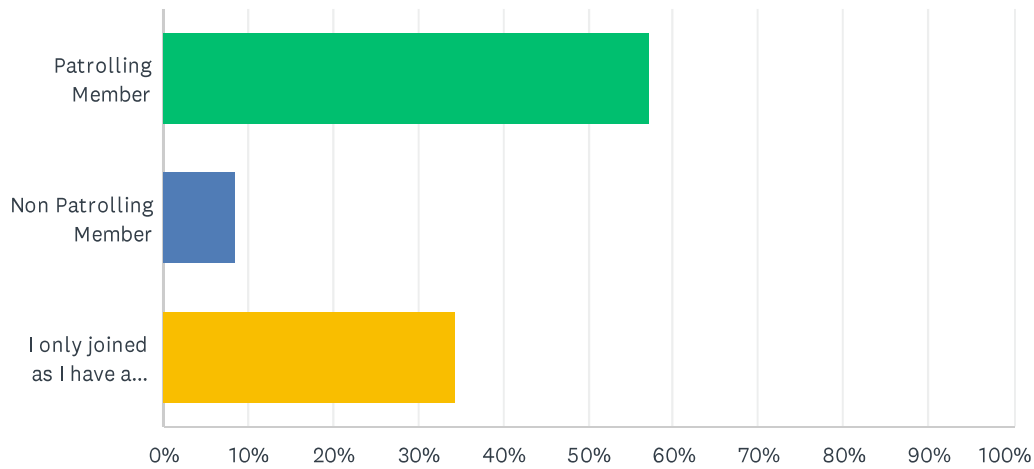

Q3 Please select the category that best describes your membership.

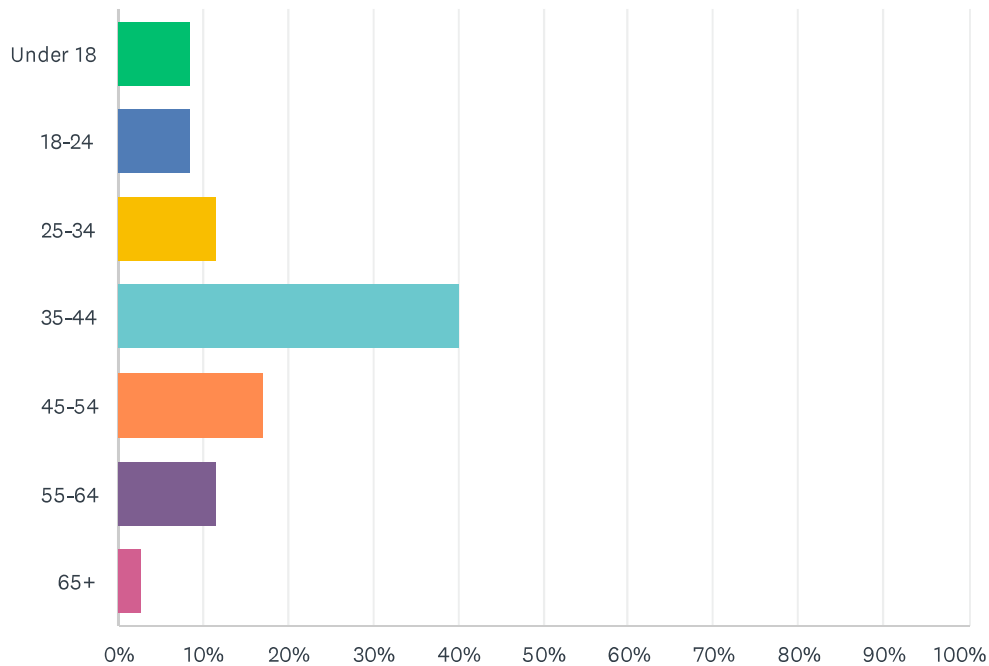

Q4 What is your current age?

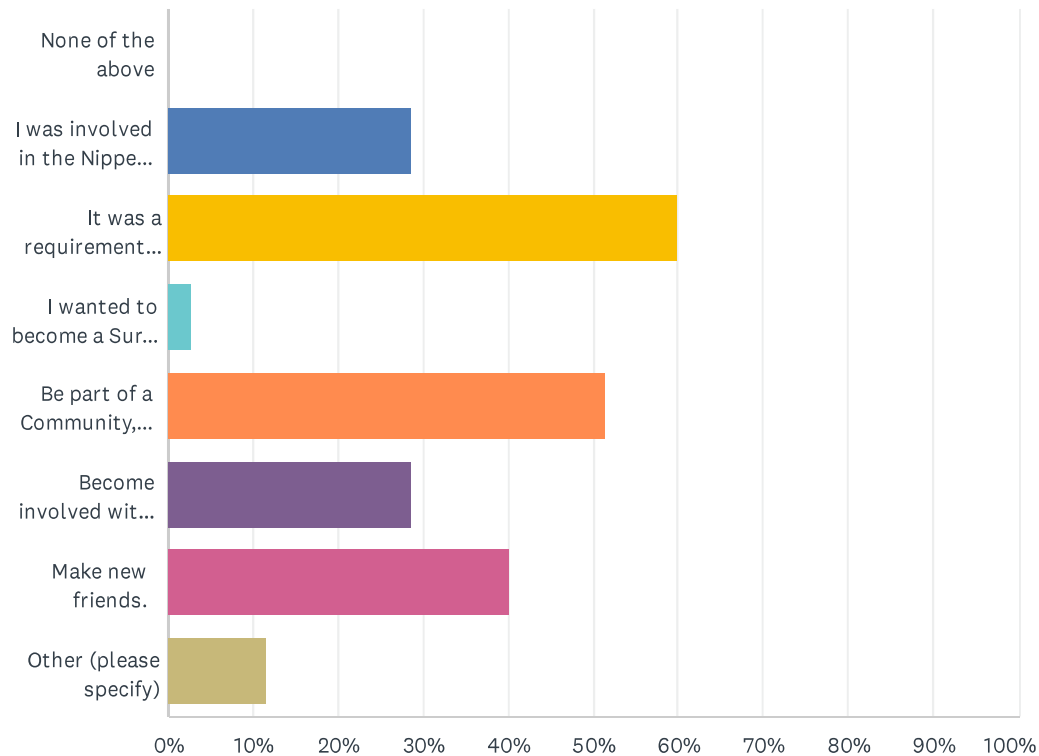

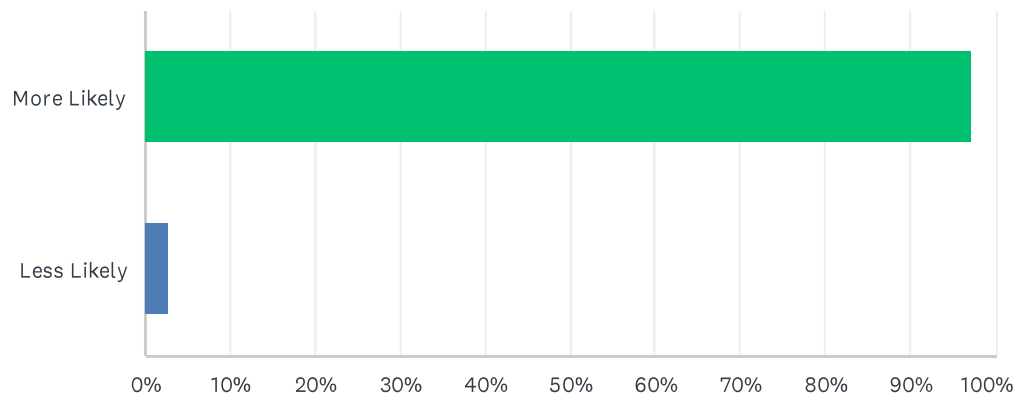

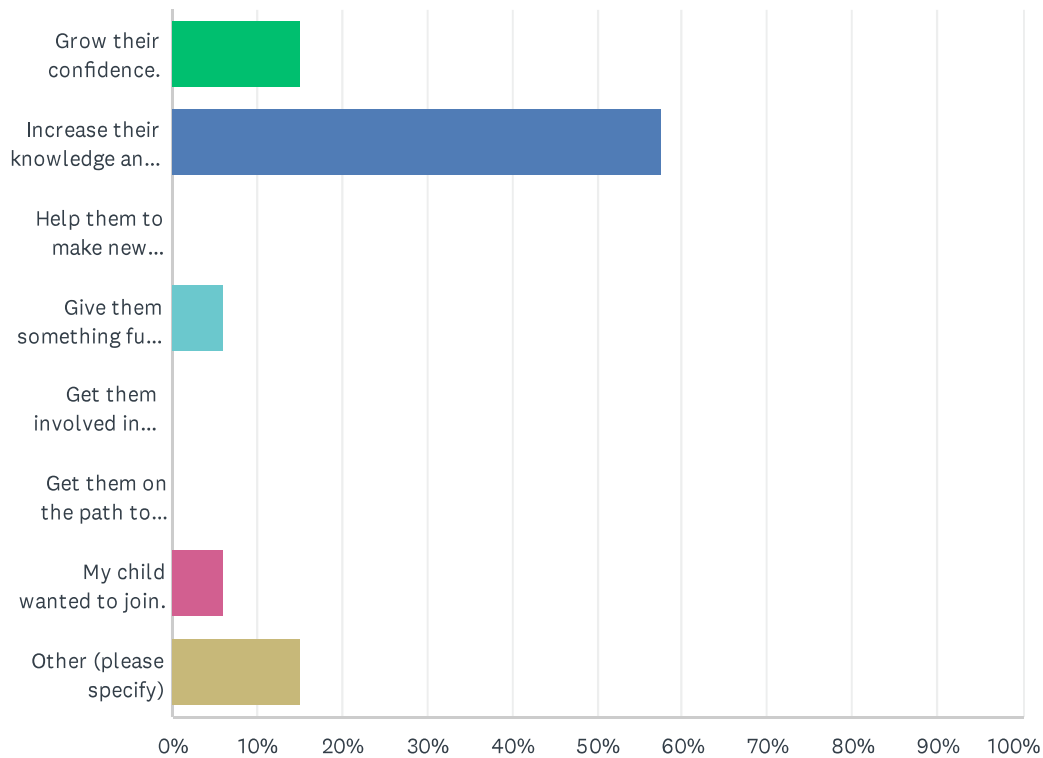

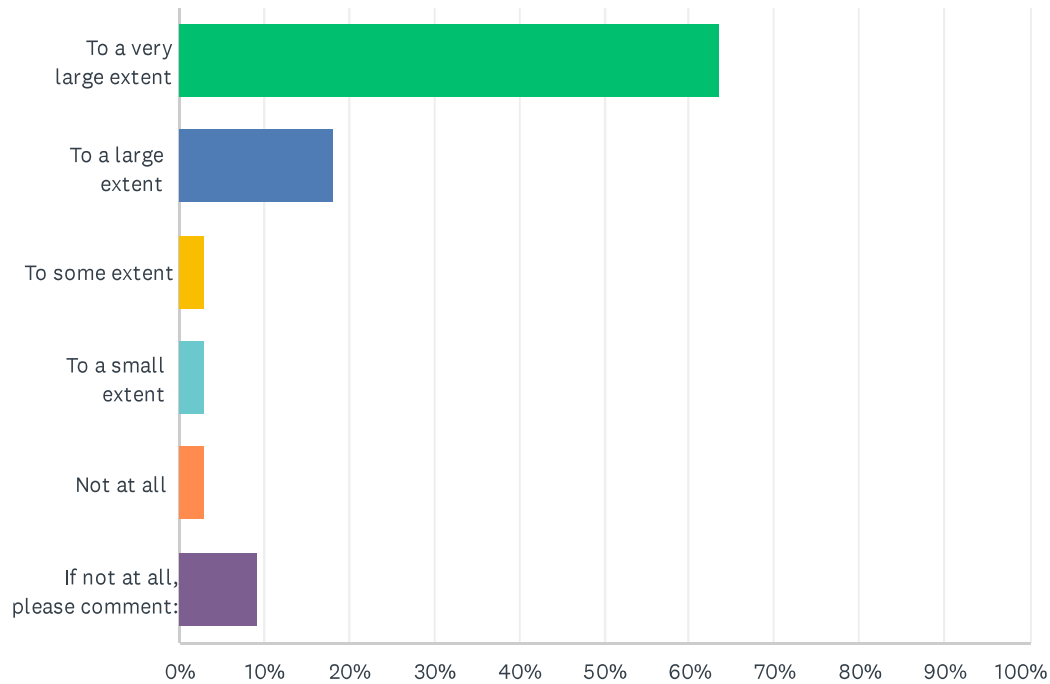

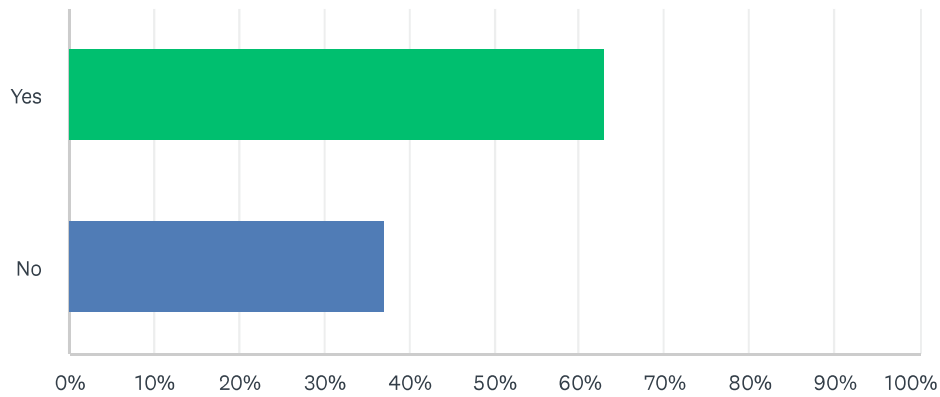

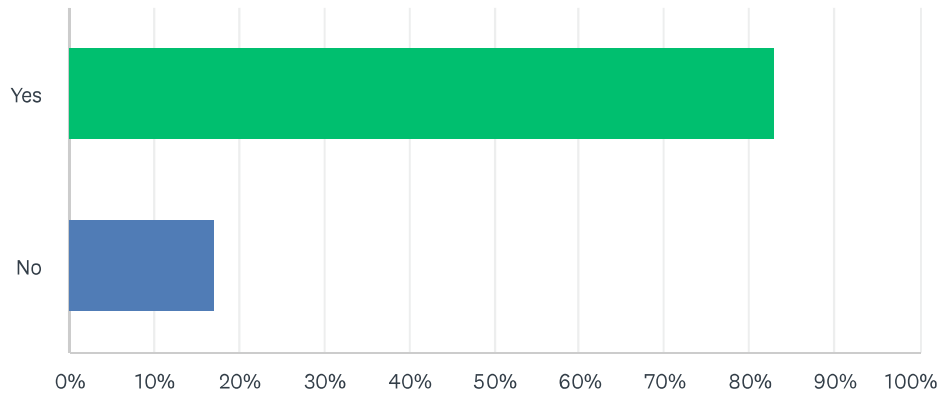

Q18 Would members be interested in a long sleeve style Club T-Shirt with either the Surfclub or Twilight Rock on it?

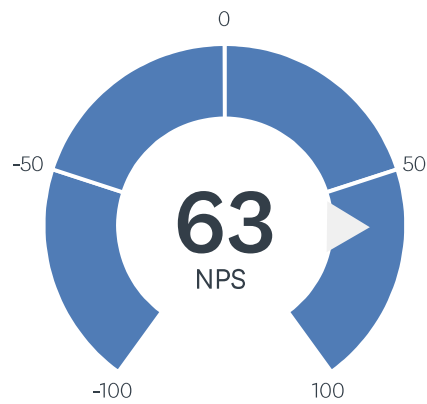

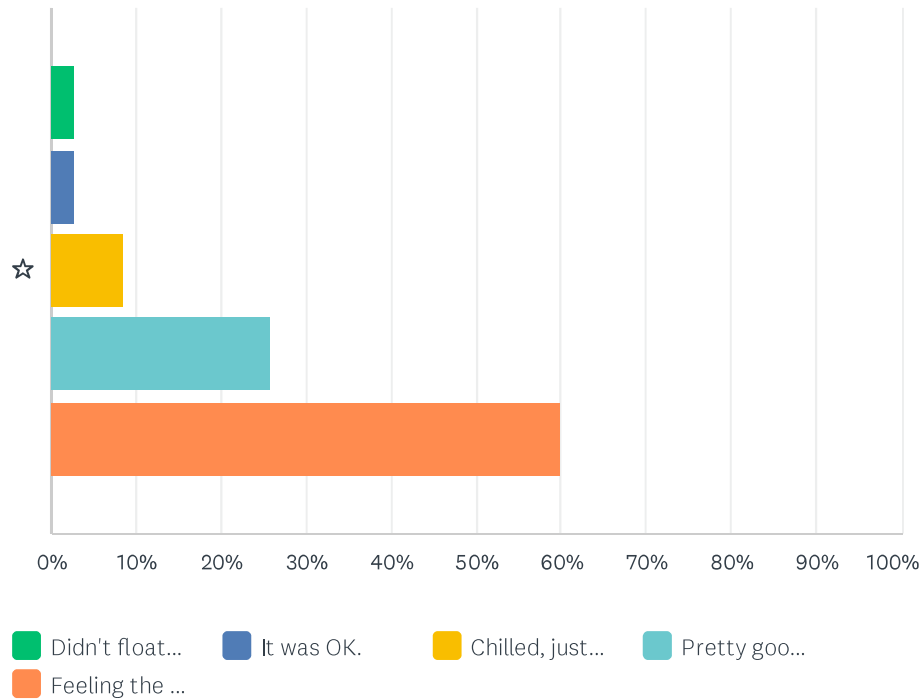

NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 30 APRIL 2022

The financial statements cover Esperance Goldfields Surf Lifesaving Club Inc as an individual entity. Esperance Goldfields Surf Lifesaving Club Inc is a not-for-profit association incorporated in Western Australia under the Associations Incorporation Act 2015.

Comparatives are consistent with prior years, unless otherwise stated.

1 Basis of preparation

In the opinion of the committee of management, Esperance Goldfields Surf Lifesaving Club Inc is not a reporting entity since there are unlikely to exist users of the financial statements who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. These special purpose financial statements have been prepared to meet the reporting requirements of the Act.

The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting Interpretations, and the disclosure requirements of AASB 101 Presentation of Financial Statements, AASB 107 Statement of Cash Flows, AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054 Australian Additional Disclosures.

The association is preparing special purpose financial statements since it is not required to prepare General Purpose Financial Statements due to its limited turnover and is awaiting introduction of the Tier 3 Differential Reporting Framework.

The financial statements have been prepared on an accruals basis and are based on historical costs modified, wherer applicable, but the measurement at fair value of selected no-current assets, financial assets and financial liabilities.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of this financial report.

The financial statements and material accounting policies all comply with the recognition and measurement requirements in the Australian Accounting Standards.

2 Summary of significant accounting policies

Income tax

The association is exempt from income tax under Division 50 of the *Income Tax Assessment Act 1997*.

Revenue and other income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Association and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

Sale of goods

Revenue is recognised on transfer of goods to the customer as this is deemed to be the point in time when risks and rewards are transferred and there is no longer any ownership or effective control over the goods.

Interest revenue

Interest is recognised using the effective interest method.

Goods and services tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of GST.

Cash and cash equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

Property, plant and equipment

Each class of property, plant and equipment is carried at cost less, where applicable, any accumulated depreciation and impairment.

Plant and equipment is depreciated on a straight-line basis over the assets useful life to the Association, commencing when the asset is ready for use.

At the end of each annual reporting period, the depreciation method, useful life and residual value of each asset is reviewed. Any revisions are accounted for prospectively as a change in estimate.

Inventories

Inventories are measured at the lower of cost and net realisable value. Cost of inventory is determined using the first-in-first-out basis and is net of any rebates and discounts received. Net realisable value is estimated using the most reliable evidence available at the reporting date and inventory is written down through an obsolescence provision if necessary.

Impairment of non-financial assets

At the end of each reporting period, the association determines whether there is an evidence of an impairment indicator for non-financial assets.

Where this indicator exists and regardless for goodwill, indefinite life intangible assets and intangible assets not yet available for use, the recoverable amount of the assets is estimated.

Where assets do not operate independently of other assets, the recoverable amount of the relevant cash-generating unit (CGU) is estimated.

The recoverable amount of an asset or CGU is the higher of the fair value less costs of disposal and the value in use. Value in use is the present value of the future cash flows expected to be derived from an asset or cash-generating unit.

Where the recoverable amount is less than the carrying amount, an impairment loss is recognised in profit or loss.

Reversal indicators are considered in subsequent periods for all assets which have suffered an impairment loss, except for goodwill.

Scope
